Explanation of Responses:

1. The reported transactions involve an amendment applicable to outstanding unvested options, resulting in the deemed cancellation of the "old" options and the grant of replacement options. The options were originally granted on April 4, 2008 and provide for vesting in up to five equal annual installments, based on the level of LNTH's satisfaction of certain performance criteria for each of fiscal years 2008, 2009, 2010, 2011 and 2012. The amendment provides for additional vesting on the third anniversary of the amendment date (or the day before any earlier expiration) of any options that remain unvested at that time.
